NOTICE OF PUBLIC AUCTION SALE

1. The following armored car owned by Embassy of Italy in Riyadh is on sale:

Please note:

- The body and interior are in good condition

Defects:

- Battery to be replaced
- 12v 2Ah battery for safety systems to be replaced
- Control unit to be replaced
- "Runflat" tires and armored rims to be replaced
- Braking system to be checked (possible change of brake discs and pads)
- Air conditioning system to be controlled (possible A/C recharge and cleaning)

2. The Auction's Starting Price

The Auction's Starting Price is fixed in SAR 3000.

All expenses (re-registration, registration of change of ownership, etc.) are charged to the purchaser.

3. Procedures of carrying out the auction

- a) The auction will take place by the submission of secret bids, equal to or higher than the auction's starting price.
- b) Purchase bids must be received by this Embassy within the deadlines and according to the procedures laid down in points 4, 5 and 6.
- c) The auction, subject to the provisions of the general conditions, will be cancelled if at least one valid offer will not be submitted.

4. Persons allowed to submit bids and participation requirements

All individuals, natural or legal persons, meeting the following requirements are eligible to participate at the auction:

- d) inexistence of conditions of impossibility to enter into contract with the Public Authorities as well as any other situation considered by the law prejudicial or limiting the capacity of contracting (Article 80 of Legislative Decree 50/2016)
- e) no bankruptcy proceedings

Proxy bids are not allowed, except for legal representatives of legal entities - be they public or private - and of companies that carry out business activities.

Members of the tender commission are not eligible to participate.

5. Terms of participation and procedures of submitting bids

For the purposes of participation in the tender, the interested parties must send, under penalty of exclusion, the envelope containing the purchase offer by and no later than 12 noon on 28 March 2019. The envelope can be:

- a) sent by registered mail of the postal service within 7 days from the date of the opening of bids: in this case the date of the postmark will be taken as proof.
- b) delivered by hand at the Embassy's Accounting Office, from Sunday to Thursday, from 9.00 to 15.00, by the interested party or through private couriers or delivery agencies or by another person in charge: in this case a receipt will be issued indicating the time and date of delivery.

Applications and documentation received after the above described deadlines will not be taken into account. The risk of delivery is the sole responsibility of the sender. The Administration is not liable for loss or delay for whatever reason (postal error, deriving from acts of third parties, due to an accident or force majeure).

6. Required Documentation

Participants must produce, under penalty of exclusion, the following documentation:

- a) Contact details for any communication;
- b) Indication of the entity which will sign the contract and settle the related fee;
- c) The auction bid. The bid must be valid for 30 days from the date of submission.
- d) Declaration attesting the appropriate qualification/license to keep an armored car in line with local regulations.

7. Submission of the Bid

Within the time limit referred to in point 4, the bid must be received in a proper envelope, as specified below:

- c) **Sender:** sender's personal details and address
- d) **Integrity of the envelope:** To ensure its integrity, the envelope must be closed and countersigned on the closing flaps.

8. Public session of the opening of tenders

The Evaluation Committee, appointed for this purpose by the deadline for the submission of tenders, proceeds to open the envelopes and examines the documentation attached to them on **28 March 2019, at 2:00 pm**, in public session, open to competitors who have submitted a tender, as well as to the individuals with an appropriate proxy.

Subject to the provisions of the general conditions, the award of the contract shall take place in favor of the party who has submitted the highest economic offer, even when there was only one valid offer, provided that it was considered appropriate and suitable.

The offered price must be equal to or higher than the auction's starting price. Lower offers will not be accepted.

Bids that are conditional or expressed in an undetermined manner or with a simple reference to another offer of their own or of others shall not be admissible. The offer must be expressed in figures and in letters; in case of discrepancy, the most advantageous amount for the Administration will prevail.

9. Equality of received bids. Raising

When two or more tenderers advance the same offer, these alone, if present, will be invited, through secret bidding method, to submit a new offer during the same session, provided that they agree on this arrangement. In the event of non-simultaneous presence or non-agreement on the immediate submitting of new offers, the same tenderers will be invited to submit a new offer within 2 days of the session, in the same way as for the first offer.

Once the envelopes have been delivered, the successful tenderer will be the one whose bid is the highest. If the competitors who produced the same offer would not agree to improve the offer, or the new offer is again of the same amount, the winning bidder will be chosen by draw.

10. Pre-emption rights

This auction shall not affect the exercise of the right of first refusal by any entitled parties.

11. Effects of the awarding's report

The awarding's report will not have the effect of the contract of sale. Therefore, it will be necessary to proceed with the signing of the deed of sale through the procedures that will be announced at a later date.

12. Conditions of sale

The above car shall be alienated as is in its de facto and de jure situation at the relevant. The buyer will be responsible for any charges related to the possession and use of the car in accordance with the regulations in force in Saudi Arabia.

No claim or dispute shall be admitted either before or after the transfer of ownership. The Embassy shall not be liable for the state of maintenance and operation of the car and therefore no responsibility for the future use by the new owner may be borne by the Embassy.

The above car will be immediately available as from the moment of signing contract of sale.

13. Obligations of the buyer and the Administration

The buyer will be obliged in connection with all the effects arising from the conclusion of the deed of sale.

14. Renouncement of the buyer

In case of renunciation or if the definitive winning bidder does not show up for the signing of the contract of sale by the notified due date, he will lose all rights. In this event, the Embassy of Italy in Riyadh reserves the right to consider awarding the car to the second highest bidder or to activate a new tendering procedure.

The treatment of the data received, which constitutes a condition of participation in the auction, will only be for the purposes referred to in this notice of auction and in accordance with Legislative Decree 196/2003 and the General Data Protection Regulation (EU) 2016 / 679.

4. Bid rigging

Actions will be pursued, according to the terms of the respective Penal Codes, against anyone who, by violence or threats or with gifts, promises, collusion or other fraudulent means, obstructs or disrupts the tender, or turns away bidders and against anyone who refrains from competing for money or other benefits given or promised to him or to others.
