## THE AMBASSADOR OF ITALY

CONSIDERING the need to launch a selection procedure to assign tasks to design and manage a detailed project, and the subsequent public tender for the execution of extraordinary maintenance works in the residences of the Italian Mission in Riyadh, and that the next phases will involve the launching of a first market survey for the selection of a technician in support of the Procedure Responsible Officer and the subsequent survey, with the aim of identifying a professional body for the detailed design and construction supervision.

CONSIDERING that the values for the compensation of the technical support to the Procedure Responsible Officer, and for the designer-director of the works are well below the threshold of 40 thousand euro, according to what can be inferred from the calculation governed by the tables attached to the Decree of the Italian Ministry of Justice of 17 June 2016. In both cases, as in art. 31, paragraph 8 of Legislative Decree no. 50/2016, it is intended to proceed with the direct award, subject to market survey and acquisition of at least two proposals;

IN VIEW of Decision No. 10 of 23/02/2001 of the National Anti-corruption Authority, on "issues concerning liability of the procedure" of the authority for overseeing public works, which states that "the act of appointment should involve an ad hoc measure, with a certain date ";

IN VIEW of the National Anti-corruption Authority guidelines concerning the Procedure Responsible Officer:

## **DECIDES:**

- 1. To consider the abovementioned introductory statements as an integral and essential part of the present measure;
- 2. To initiate the procedure for the accomplishment of the extraordinary maintenance work of the Mission's residences with a maximum amount of 368,205 Euros, based on the technical survey;
- 3. pursuant to art. 9 of Presidential Decree No. 207 of October 5, 2010, to appoint 1st Counsellor, Deputy Head of Mission of the Italian Embassy in Riyadh, Davide Marotta, who meets the necessary requirements in accordance with Act 241/90 and Legislative Decree 50/16, as the Procedure Responsible Officer of the extraordinary maintenance works, adjustment of technological systems and security aspects of the residences of the Italian Mission in Riyadh;

- 4. To give Counselor Davide Marotta the power of signature regarding to acts of direct competence in his capacity as the Procedure Responsible Officer and in limits permitted by the current regulations, respecting the chain of command;
- 5. To give the Procedure Responsible Officer the mandate to directly select and appoint, given that the anticipated costs fall below the value of 40,000.00 Euro, a technician supporting the Procedure Responsible Officer;
- 6. To give the Procedure Responsible Officer the mandate to select and appoint, by a separate direct award, if the expected costs fall below the value of 40.000,00 Euro, a professional with appropriate technical skills and proven experience as a designer and project manager for the subject intervention;
- 7. once the final design is approved, to proceed with the tender for the implementation of the works with the help of a negotiated procedure;
- 8. To establish that the amounts necessary for the accomplishment of the work are to be financed from the maintenance fund of which the first part was assigned to this Embassy with the maintenance fund 7248/2016 for an initial amount of €200,000, 00;
- 9. To provide that the relevant contracts will be awarded by private agreement or by correspondence in line with commercial practice consistent with the appropriate exchange of letters, and even via certified email;
- 10. To notify the Procedure Responsible Officer of this Decision;
- 11. To adequately publish the present act where appropriate.
